Sarada Charan Dey College, Kalinagar - III, Hailakandi, Assam- 788801, a higher learning institute having expertise in the areas of Arts, Commerce, Education and Research; affiliated to Assam University, Silchar hereinafter referred to as Sarda Charan Dey College, Kalinagar - III, Hailakandi, Assam- 788801, the SECOND PARTY, for the purpose of exchange of Faculty, Staff and Students, Sharing Resource, Sharing between IQAC. The aforesaid institutions are hereinafter referred to individually as institute and collectively as institutes.

#### Preamble

WHEREAS, Jagannath Singh College, Vill- Dayapur Part-II, P.O.- Udharbond, Cachar, Assam, PIN-788030and Sarada Charan Dey College, Kalinagar - III, Hailakandi, Assam- 788801, have many areas of common interest, a considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research.

NOW THEREFORE, Jagannath Singh College, Vill- Dayapur Part-II, P.O.- Udharbond, Cachar, Assam, PIN-788030 and Sarada Charan Dey College, Kalinagar - III, Hailakandi, Assam- 788801, have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two institutes set forth in the following sections.

#### **ARTICLE-1: OBJECTIVE**

Both institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity. The two institutes shall seek to promote:

#### a. Faculty/Staff Exchanges

- i. The exchange of faculty to the mutual benefit of both institutes,
- ii. Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest,
- iii. The exchange of academic materials and publications,
- iv. Conducting lectures,
- v. Undertaking joint research,
- vi. Attachment of staff for purposes of curriculum development and review, attendance of courses, upgrading of teaching and research skills,
- vii. Participating in seminars, symposiums, and other types of academic discussions, viii. Conducting study tours and joint consultancy work.

### b. Student Exchange

Jagannath Singh College, Vill- Dayapur Part-II, P.O.- Udharbond, Cachar, Assam, PIN-788030and Sarada Charan Dey College, Kalinagar - III, Hailakandi, Assam- 788801, agree to exchange students as and when necessary and that student exchange will be guided by the principles listed hereunder:

- i. A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate
- ii. A host institution refers to the institution that receives a student for a brief period of time for the student to undertake pre-determined programme(s) of study.

#### c. Other Areas:

To ensure and promote collaboration and co-operation in other areas, both the institutes hereby agree upon to –

- i. exchange information on research and educational programmes,
- ii. exchange information on teaching, learning and other resources relevant to their educational and research programmes,
- iii. jointly organise short-term/continuing education programmes on topics of mutual interest and to invite each other's faculty to participate therein,
- iv. jointly organise seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein,
- v. propose and engage jointly in research or training programmes sponsored by funding agencies, and to invite each other's faculty to participate therein,
- vi. exchange, on a reciprocal basis, students for limited periods of time for the purpose of education and/or research,
- vii. permit students, staff and faculty members to use library facility,
- viii. provide provisions of cultural and intellectual enrichment opportunities for staff and students of both institutes,
- ix. jointly organize various co-curricular activities like games-&-sports, debates, quiz, declamation, etc., x. jointly organize various outreach activities and community development/awareness programmes, and; xi. jointly form various clubs like Debate Club, Quiz club, Eco Club, etc.

Jagannath Singh College, Vill- Dayapur Part-II, P.O.- Udharbond, Cachar, Assam, PIN-788030and Sarada Charan Dey College, Kalinagar - III, Hailakandi, Assam- 788801, agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two institutes. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

# **ARTICLE-2: CO-ORDINATION**

Each institution shall appoint one member of its teaching/research faculty to co-ordinatethe programme(s) on its behalf. Further, a co-ordination committee consisting of a programme coordinator from the side of Jagannath Singh College, Vill- Dayapur Part-II, P.O.- Udharbond, Cachar, Assam, PIN-788030and a programme coordinator from the side of Sarada Charan Dey College, Kalinagar - III, Hailakandi, Assam- 788801, will periodically review and identify ways to strengthen co-operation between the two institutions.

### ARTICLE-3: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MoU shall be vested in both institutes to this Memorandum. Any publication regarding such intellectual property shall only be possible with the prior written consent of both institutes and such consent not to be unreasonably withheld. Both the institutes shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research educational, clinical and publication purposes without the payment of royalties or other fees to the other party.

#### ARTICLE-4: VALIDITY

The Memorandum shall remain in force for a period of 5 (FIVE) years commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

#### **ARTICLE-5: TERMINATION**

Either institution may terminate the MoU by giving written notice of six months in advance to the other institution. Once terminated, neither Jagannath Singh College, Vill- Dayapur Part-II, P.O.- Udharbond, Cachar, Assam, PIN-788030nor Sarada Charan Dey College, Kalinagar - III, Hailakandi, Assam- 788801, will be responsible for any losses, financial or otherwise, which the other institution may suffer. This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.

# ARTICLE-7: ADHERENCE TO LAWS

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the land and rules and regulations of both the institutes.

# **ARTICLE-8: LEGAL EFFECT**

Nothing in this Memorandum shall be construed as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

## **ARTICLE-9: DISPUTE RESOLUTION**

In case, there be any dispute relating to any aspect of academic co-operation, Coordinator, IQAC, Jagannath Singh College, Vill- Dayapur Part-II, P.O.- Udharbond, Cachar, Assam, PIN-788030and Coordinator, IQAC, Sarada Charan Dey College, Kalinagar - III, Hailakandi, Assam- 788801, will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility. - d) Understanding joint research at the faculty level.
- e) Facility exchange relating to Laboratory, ICT and Library resources.
- f) Any other areas as mutually agreed upon by the Parties.

#### 3. LOCATION OF ACTIVITIES

- a) The Parties agree to implement the programs stated in ARTICLE 2 at MDC and JSC.
- b) Any changes to the location of the programs shall be mutually agrees upon by the Parties.

#### 4. EXECUTING AGENCIED

To implement this MOU:

- a) MDC appoints the Head of the Institution, MDC (hereinafter referred as MDC ref)
- b) JSC appoints the Head of the Institution JSC (hereinafter referred as JSC ref)

#### 5. FINANCIAL ARRANGEMENT

- a) Any cooperation under this MOU is subject to the availability of funding sources and approval by relevant authorities.
- b) Any specific project of joint interest will be detailed in a separate agreement, including financial and program specific arrangements.

#### 6. INTELLECTUAL PROPERTY RIGHTS

- a) Each Party shall protect, within its capacity and territory, intellectual property rights of the other Party in accordance with the laws and regulations in force in the state of Assam and the country of India.
- b) In case of specific arrangement, programs or projects that may result in intellectual property, the Parties shall conclude separate arrangement in accordance with the prevalent laws and regulations in the state of Assam and the country of India.

#### CONFIDENTIALITY:

In the event that either Party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MOU, the disclosing Party shall have prior written consent of the other Party.

#### E. LIMITATION OF PERSONAL ACTIVITIES :

The Parties shall ensure that their personnel engaged in the activities under this MOU shall engage only in the activities under the framework of this MOU with respect to laws and regulations in the state of Assam and the country of India.

#### 9. SETTLEMENT OF DISPUTES:

Any dispute concerning the implementation and/or application of this MOU shall be settled amicably through consultation or negation between the Parties.

#### 10. AMENDMENT:

- This MOU may be amended or revised at any time by mutual written consent of the Parties and such amendment shall form and integral part of this MOU.
- Such amendment or revision shall come into force on the date as may be determined by the Parties.

#### ARTICLE - 11

### 11. ENTRY INTO FORCE, DURATION AND TERMINATION:

- a) This MOU shall enter into force on the date of signing.
- b) This MOU shall remain in force for a period of 5 (five) years and may be extended for another period of 5 (five) years by mutual consent of the Parties.
- Either Party may terminate this MOU at any time by given written notification to the other Party on its intention to terminate this MOU, 6(Six) months prior to the date of the termination
- d) The termination of this MOU shall not affect the completion of any programs or projects in progress and not completed at the time of termination.
